

## **IMPROVEMENT COMMISSION**

**(Meetings are scheduled the first Wednesday of every month at 6:00 PM)**

The City Council hereby establishes a new commission to serve as the Urban Renewal Agency of the city (new commission). Such new commission shall continue to be known as the Improvement Commission and shall be composed of 14 commissioners. The Mayor and members of the Council shall serve as commissioners and each of them shall appoint one resident of the city to serve as commissioners. The terms for the Mayor and Councilors shall be the same as the terms of their elective office, and for appointed members, the same as the elective terms of those officials appointing them. The appointments shall be filed with the City Auditor and all commissioners shall assume office upon their taking the oath or affirmation of office to be administered by the Auditor of the city. The time and place of the first meeting of the Commission shall be determined by the Mayor. The City Auditor shall cause notice of the time and place of such meeting to be delivered or mailed to each commissioner no later than three days prior to the date set for such first meeting. The Commission shall elect a Chairperson, adopt by-laws, and determine the time and place for subsequent meetings of the Commission.
