### **Zoom Participation**

If you wish to provide public comment via Zoom, please submit your request to speak by noon, the day of the meeting, to <u>publiccomment@cityofseaside.us</u> or via this web form. Please include the name that appears on your Zoom account (you must register to use this method) and the subject of the public comment.

You will not be allowed to participate in this meeting if you do not provide all the requested information or if you provide fake or fraudulent information.

To make a public comment through the Zoom link, the device you use to access the link must have a microphone. When logging into the meeting, please ensure the name listed on the attendee list is the name you submitted. It is also helpful for you to "raise your hand" on the Zoom software to indicate you are there to make a public comment so your name will rise to the top of the attendees list. The Zoom link may be found on the agenda page of our website. Testimony through the Zoom web conference will be limited to three (3) minutes. You are encouraged to test your connection ahead of time. #### Additional Rules, Conditions, and Terms of Participation

Accurately providing all information requested is required as a condition of participating and offering public comment during this meeting. You will not be allowed to participate in this meeting if you do not provide all the requested information or if you provide fake or fraudulent information.

Information provided in this context will only be used for the governmental purpose of facilitating this public meeting. It will not be sold, but anything stated during a public meeting may be aired on television or made available for streaming via YouTube if recorded. Any information provided in written or recorded form will constitute a public record and may be required to be disclosed under the Oregon Public Records Law if a request for the information is made according to that Law.

# The City of Seaside reserves the right to terminate your public comments during the meeting if they include statements that:

• are fraudulent, defamatory, harassing, embarrassing, sexually explicit, profane, obscene, intimidating, defamatory or otherwise unlawful or inappropriate;

• promote or perpetuate discrimination based on race, gender, color, religion, age, national origin, disability, creed, gender identity, or sexual orientation;

• target any ethnic, racial, age or religious group, gender, sexual orientation, national origin, gender identity or disability status;
