

ORDINANCE NO. 2022-06

AN ORDINANCE OF THE CODE OF ORDINANCES, SEASIDE PROVIDING FOR THE REALIGNMENT OF THE WARD BOUNDARIES IN THE CITY OF SEASIDE, OREGON; REPEALING ORDINANCE 2011-08 AND ALL ORDINANCES IN CONFLICT; AND DECLARING AN EMERGENCY

WHEREAS, it is required by charter after a census or census estimates indicates that the boundaries deny equal protection of the laws, the Council shall respecify the boundaries so as to accord equal protection of the laws, and;

WHEREAS, the Charter of the City of Seaside, as amended, allows the City Council of this municipality to realign existing ward boundaries by ordinance, and;

WHEREAS, the City of Seaside acting through its City Council has deemed it advisable to provide for an equitable distribution of residents within the respective wards of the City of Seaside, following the certification of the 2020 census,

NOW, THEREFORE, THE CITY OF SEASIDE ORDAINS AS FOLLOWS:

SECTION 1. That after duly considering the population of the present wards in the City of Seaside, it is determined that it is necessary to realign the existing ward boundaries in compliance with the existing law, and such wards are hereby realigned and redefined geographically as follows:

- A. **WARD I** of the City of Seaside, County of Clatsop and State of Oregon, shall hereinafter be bounded and described as follows:

Beginning at a point from the southernmost point within the City of Seaside, proceed: Clockwise following city limits, to the westerly extension of Avenue G; Easterly along Avenue G; Northerly along S. Holladay Dr to Avenue F; Easterly along Avenue F and its extension to the western bank of Neawanna Creek; Southerly following the western bank of Neawanna Creek to the city limits; Clockwise following city limits to the point of origin.

- B. **WARD II** of the City of Seaside, County of Clatsop and State of Oregon, shall hereinafter be bounded and described as follows:

Beginning at a point from the intersection of S Roosevelt Dr and Avenue F, proceed: Westerly along Avenue F; Southerly along S Holladay Dr; Westerly along Avenue G and its westerly extension to the city limits; Clockwise following city limits to the eastern bank of the Necanicum River (along the westerly extension of Venice Blvd); Southerly along the eastern bank of the Necanicum River; Easterly along 12th Avenue; Southerly along N Holladay Dr; Easterly along 10th Avenue; Southerly along N Roosevelt Dr/S Roosevelt Dr to the point of origin.

- C. **WARD III** of the City of Seaside, County of Clatsop and State of Oregon, shall hereinafter be bounded and described as follows:

Beginning at a point from the intersection of city limits at the eastern bank of the Necanicum River (along the westerly extension of Venice Blvd), proceed: Clockwise following city limits to the point of intersection between city limits and 2020 Census tabulation block 410079511001009 (Stanley Lake); Southerly along the border of block 410079511001009 to the intersection with city limits; Clockwise following city limits (westerly) to Neawanna Creek; Southerly along Neawanna Creek to the point of intersection with 2020 Census tabulation block 410079509002050 (the westerly extension of Shore Terrace); Easterly along the western extension of Shore Ter to N Wahanna Rd; Southerly along N Wahanna Rd to the point of intersection with 2020 Census tabulation block 410079509001013; Counter-clockwise along block 410079509001013 to the western bank of the Necanicum River; Southerly along the western bank of the Necanicum River to the easterly extension of Avenue F; Westerly along Avenue F; Northerly along S Roosevelt Dr/N Roosevelt Dr; Westerly along 10th Ave; Northerly along N Holladay Dr; Westerly along 12th Ave; Northerly along the east bank of the Necanicum River to the point of origin, Excluding all points outside of city limits within the preceding description.

D. **WARD IV** of the City of Seaside, county of Clatsop and State of Oregon, shall hereinafter be bounded and described as follows:

Beginning at a point from the intersection of the western bank of Neawanna Creek with city limits, proceed: Northerly along the western bank of Neawanna Creek to the intersection with 2020 Census tabulation block 410079509001000; Counter-clockwise along the perimeter of 2020 Census tabulation block 410079509001000 to the centerline of S Wahanna Rd; Northerly along S Wahanna Rd/N Wahanna Rd to the intersection with 2020 Census tabulation block 410079509002018 (Shore Ter); Clockwise around the perimeter of 2020 Census tabulation block 410079509002018 to the centerline of the Neawanna Creek; Northerly along Neawanna Creek to the intersection of 2020 Census tabulation block 410079509002002 and city limits; Clockwise following city limits to the northwesternmost point of 2020 Census tabulation block 410079511001009 that is within Stanley Lake and city limits; Clockwise following city limits to the point of origin, Excluding all points outside of city limits within the preceding description.

SECTION 2. EMERGENCY CLAUSE. That inasmuch as this Ordinance is necessary for the immediate preservation of the public health, safety, and welfare of the City of Seaside, and to assure compliance with existing state law within time constraints; an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage by the City Council and approved by the Mayor.

SECTION 3. Ordinance No. 2011-08 and all ordinances in conflict shall be repealed.
